1. INSTRUCTIONS TO TENDERERS:

Hence the tenderers are requested to make proper arrangements for it. The Board will not be responsible for any loss or delay in transit of the Tender documents.

- b. In case, if the Tenderer, feels that there is any ambiguity in any clause and condition of the specification, the Tenderer should get it clarified before submitting his tender and wants any clarification after submitting the Tender after opening of Tenders, the interpretation of such clause and condition as made out by the CHIEF ENGINEER CHENNAI NORTH TNEB CHENNAI 600002 will be final and will be binding on the Tenderer. - c. The CHIEF ENGINEER CHENNAI NORTH TNEB CHENNAI 600002 is the sole and final authority for deciding any points, any clarification of disputes arising during the sale of the materials and such decision is not for any further reference to any authority.
- d. Tenders shall be subject to all the conditions stipulated in the Tender specification. Any other conditions or counter offers stipulated by the tenderer in their Tenders will not be accepted.
- e. No suit or proceeding in regard to any matter arising any respect under this contract shall be instituted in any court of law save in the city, Civil court of Chennai or the court of small cases at Chennai. It is agreed that no other court shall have jurisdiction to entertain any suit of proceedings even though part of the cause of action might arise within their jurisdiction. In case jurisdiction of any of the courts in Tamil Nadu and not in courts of Chennai city then it is agreed to between two parties that such suits or proceeding shall be instituted in a court within Tamil Nadu and no other court outside Tamil Nadu shall have jurisdiction even though any part of the cause of action might arise within the jurisdiction of such courts.

4. EARNEST MONEY DEPOSIT

- i. The Tenderers should pay the prescribed E.M.D. of 5% of their offered total value of each lot, only in the form of D.D/Pay order obtained from a Schedule bank payable at CHENNAI (CENTRAL) and enclosed along with the sealed Tender in accordance with the Tender regulation, for consideration of Tender. The Earnest Money Deposit paid by the Tenderers will not carry any interest.

There will be no exemption to S.S.I and N.S.I units from payment of E.M.D and therefore all tenders without the prescribed EMD will not be opened and will be summarily rejected

- f. Tenders received without quoting firm rate both in figures and words separately for each lot to the tender schedule
- g. Tenderers received without the signature of the Tenderer in the tender form concerned
- h. Tenderers should not stipulate their own terms and condition and their own validity period for the rates quoted by them either in the Department Tender Forms or in separate letter along with the tender.
- i. The Tender form purchased by the tenderer from outside Tamil Nadu should not be submitted in the name of their branch office situated in the State of Tamil Nadu. Such tender will be summarily rejected.
- j. The Earnest Money Deposit specified above should be deposited by means of demand draft drawn in favour of the CHENNAI (CENTRAL) and obtained from anyone of the scheduled Banks payable at a Branch situated at Chengalpattu. The above demand draft should be kept either on the inner Tender Cover or in the outer cover

- a. The Tenderer should quote firm prices both in figures and words separately for each lot in the Tender form abstract the tenders should quote the rate against each lot separately. Lumpsum quotations without lot rate will not be accepted and liable for rejection. They are requested to quote the rates per lot. INSPECTION

- a. The materials can be inspected, by those who are interested in the purchase as per the terms and conditions of the specification on any working day during working hours. - c. The inspection of the materials will be permitted to the parties who have produced the copy of specification to the Officers in charge of the above concerned stores.
- d. The successful tenderers will not be permitted to bring dealers or merchants for inspection of materials of further examination of materials in the stores premises when once the tenders are finalized.

PAYMENT AND DELIVERY

- i. The successful tenderers should remit 100% cost of accepted lot in D.D payable at Chengalpattu only, less E.M.D paid to the lot, to the Superintending Engineer, Chengalpattu Electricity Distribution Circle within 21 Days from the date of receipt of sale order from Chief Engineer/ Distribution South / Chennai and produce the cash receipt to the Superintending Engineer / CEDC/ Chengalpattu , who will issue release order. The release order will be issued only on receipt of the entire amount.
- ii. As per Finance act of 2003 of Government of India U/S 206 (C) Income Tax plus Surcharge on Income Tax (as applicable) and subsequent amendment made there on will be collected at the time of remitting the sale amount.
- ii. The sale order will be issued to the successful tenderers who have submitted the quotation. No change in name or address, or transfer or sale of release order will be permitted.
- v. If the entire amount is not paid by the successful tenderer within the time stipulated above the successful tenderer backs out as per clause 2(b), the Earnest Money Deposit amount will be forfeited without further reference to him. No plea for non-remittance of the amount in time will be entertained and partial remittance is also not acceptable
- v. The purchased materials should be removed completely by successful tenderer from the Board's premises within 15 days from the date of issue of release order. The Board will not afterwards be responsible for any loss or damage to the materials not taken over.
- /i. In case of the successful tenderers failing to remove purchased materials with in the time limit specified above either partly or fully, ground rent at the rate of Rs. 10 (Rupees Ten only) per Metric Tonne or part there of per day will be collected for the unlifted quantity up to a minimum period of 15 days from the expiry date of lifting the materials and collected.
- ii. If the successful tenderer fail to remove the purchased materials completely or partially from the board's stores within 15 days from the date of issue of release order, they will not be allowed to remove the purchased materials, there after and the amount paid towards the cost of materials and the E.M.D paid by them will be forfeited to Board without further reference to the tenderer for non clearing of the purchased materials in time and request for further extension of time for lifting the materials will not be entertained the successful tenderer will have no claim for compensation whatsoever.
- ii. The Materials are for sale and delivery Ex-Board's premises under "As is where is condition." Selection or omission of materials will not be permitted. The successful tenderer should make his own arrangements for providing labor at his expenses or weighing, packing, etc. of the materials and should delivery from where they are available as per the direction of the Officers who are incharge as laid down in para 8.
- x. Materials will be handed over only to the successful tenderer or to his authorized representatives duly authorized and whose signature does he attest.

- i. Removal of materials should not in any way interfere the Board's works that may be in progress there. The purchasers employee engaged in the removal of materials shall work subject to the Boards rules and discipline.
 - ii. The Board will not be responsible for any damage or loss that the successful tenderer or his representative may suffer during the process of removal or transport of the materials. The successful tenderer is responsible for all acts of his employees and any damages to the properties of the acts of his employees and at any Board or he shall make any other person or public body in the course of movement of his vehicles and transport of the materials good. In case of accidents to any staff of this Board in the course of removal materials, the successful tenderer shall bear necessary compensation that may be awarded to the person or persons involved in the accidents according to the workman's compensation act besides arranging immediate medical aid.
- ii. The weight of the materials will be as determined in the Board's weighing scales etc. Tenderers are advised to satisfy themselves regarding the quantity and condition of the materials before tendering. The Board is not responsible for deterioration or loss in the materials side from the date of tendering to date of removal from the site and no representation about the quality and condition at the time of delivery or at anytime there after will be entertained on any account.
- v. The materials which are accounted on weight basis shall be weighed in the presence of one or two TNEB officers in the departmental weighing machine or lorry weigh-bridge from the available source and the weights recorded by the weighing machine and the Board will be final and shall be accepted by the successful tenderer. The weighing machines are periodically maintained and certified by the competent authorities.
- v. The successful tenderer shall remove the weighed quantity then and there under separate gate pass for each consignment weighment. No part of the weighed quantity will be allowed to be kept in the departmental premises after the weighments are done.
- i. The materials will be released only during the working hours in the working days of the stores(ie.8.00AM to12.30pm and 1.30pm to5.00pm). The successful tender should remove the materials from the stores premises within the working hours of the stores. The successful tenderer should also contact the officer in-charge of store in advance about the availability of the officers for releasing the materials and then only arrange for the vehicles and men for taking the delivery of materials.
 - ii. Materials removed from the stores should not be dumped outside the stores compound
 - ii. The materials will be released only on production of the release order at stores.
- x. Any loss sustained to the TNEB. on account of resale of materials due to Backing out of the successful tenderer/defaulters, the difference between the original sale value and resale value will be recovered from the defaulting tenderer of the first sale. This is without prejudice to the rights of forfeiture of EMD.

VALIDITY

- a. a. The rates offered should be valid for 120 days from the date of opening of tenders if for any unforeseen reasons/circumstance the approval of the offer is delayed the rates quoted should be valid for further period of 60 days (ie) in total the rates should be valid for 180 days.

- c. No tenderer will be allowed to withdraw the offer within the validity of 180 days specified. If tenderer before the expiry of the validity period withdraws the tender, the E.M.D paid will be forfeited. The tenderer cannot quote his own validity period and such tender will not be considered and will be totally rejected.
- d. The sale will be on Ex. TNEB. Stores basis, if any of the tenderer taking part in the sale wish to take the materials outside the State they should pay in addition to the sale price payable to Board the purchase tax applicable to the transaction to the Government of Tamil nadu before taking the materials outside the state. At present no T.N. VAT is applicable for sale of materials to tenders within the State of Tamil Nadu . However if due to the change in the law any T.N. VAT is levied of the date of sale the same will have to be paid extra by successful tenderer
- e. If any revision in the rate of T.N VAT or C.S.T is ordered by the Government at the time of release of materials the rates prevailing at what time will be levied and collected from the successful tenderer.

INCOME TAX

Income Tax @ 1% and applicable surcharge will be levied in addition to the quoted amount & education cess 3% on income tax and surcharge.

SURCHARGE

Surcharge @ 10% of Income Tax will be levied

Exemption of deduction of Income Tax @ surcharge will be considered to the buyers only who obtain such a certificate to its effect from the concerned assessment officer in the prescribed form No.67 in original within in scheduled period.

Issue of release order will be considered only on remittance of the above Tax Surcharge along with sale amount.

Tamil Nadu Electricity Board reserves the right to relax, waive or modify any of the clauses in the Tender specification wherever deemed necessary.
